

In this Privacy Statement we, EOS GmbH Electro Optical Systems (“We”) will inform you about how we process and use your personal data in connection with our online training center for customers and business partners (Additive Minds Academy) and on the specific rights you have in connection with your personal data.

Many of our customers are organizations and companies (so-called legal entities). If you contact us as an employee of an organization or a company, we will store and process the categories of data described herein below generally in relation to this organization or company, but may link it to the information that you are employed by such organization or company and are our contact person.

Scope

- Please note that this Privacy Statement applies only to use of our Additive Minds Academy. Use of our website addressed to the general public under eos.info, registration for newsletters and data processing in the context of telephone support or on-site visits are subject to our General Privacy Statement.

- Our General Privacy Statement also includes additional explanations of certain terms and concepts used herein and further information on how we handle personal data of (prospective) customers and business partners outside of the Additive Minds Academy.

Processing in the Context of our Additive Minds Academy

- When you visit our Additive Minds Academy, our web server will temporarily record the domain name or IP address of the requesting computer, the access date, the file request of the client (file name and URL), the HTTP response code and the website from which you are visiting us, the number of bytes transferred during the connection and, if applicable, other technical information that we use and statistically evaluate for the technical implementation of the Additive Minds Academy use (delivery of the content, guaranteeing the Additive Minds Academy functionality and security, protection against cyberattacks and other abuses).
- It is necessary to store and process the information referred to above for the duration of your session in order to deliver our Additive Minds Academy content to your computer.
- We also store some of this information in the log files of our servers. We will not combine this information with your IP address or other personal data relating to you.
- This processing will take place for the fulfilment of the existing contract of use with you (legal basis for processing: Art. 6 no. 1 lit. b) of the GDPR), as far as it serves the purpose of the technical implementation of the Additive Minds Academy use and to otherwise protect our legitimate interest in making our Additive Minds Academy as user-friendly, safe and attractive as possible (legal basis for processing: Art. 6 no. 1 lit. f) of the GDPR).
- To facilitate navigation on our Additive Minds Academy, we use cookies, among other things, to process the data mentioned under Section 1.

Cookies are files that are stored on your computer's hard drive and are accessed by our server when you visit our Additive Minds Academy. We exclusively employ cookies which enable us to follow your actions during the browser session as required for the technical operation of the Additive Minds Academy, and do not enable any other third party cookies.

- You can prevent or restrict the storage of cookies on your hard disk by setting your browser not to accept cookies or to request your permission before setting cookies. Once cookies have been set, you can delete them at any time. Please refer to your browser's operating instructions to find out how this works. If you do not accept cookies, this can lead to restrictions in the use of our service.
- Log files are deleted after 30 days. Our cookies expire at the end of the session. After expiry of those periods information will be deleted or made anonymous.

Processing in the Context of Registration or Communications

- If you register for use of our Additive Minds Academy and create a user account (the registration form will show you which registration data we collect and store and whether entries are mandatory or voluntary), all personal data collected in connection with this user account will be stored in this user account until you delete the user account or until we cancel the user account for the performance of our contractual relationship on use of the respective Additive Minds Academy or web service (legal basis for processing: Art. 6 no. 1 lit. b) of the GDPR). The IP address assigned to you by your internet service provider (ISP), and the date and time of registration will also be stored when you register. The purpose of this is to protect our legitimate interest in preventing and, if necessary, prosecuting misuse of our services (legal basis for processing: Art. 6 no. 1 lit. a) of the GDPR).
- After de-registration of your user account, we will retain all data for up to six months. This serves to protect our legitimate interest in being able to restore this data in the event of unintentional deletion; or in establishing, exercising or defending legal claims in connection with our contractual relationship (legal basis for processing: Art. 6 no. 1 lit. a) of the GDPR). We will assume that your interests do not conflict with this because the retention period is appropriate with respect to the interests to be protected.
- Our Additive Minds Academy contains a contact form which you can use to submit communications to us. When submitting information through the contact form, you are required to enter an e-mail address which we will use for responding to your request.
- If you provide us with personal data via the the contact form for a purpose beyond the use of the Additive Minds Academy, such as sending an offer or product information, we will also store and process this data for this purpose. In order to find more information on how we store and process such data, you will need to refer to the pertinent Section of our General Privacy Statement (see Section 2).

- If you register to use the Additive Minds Academy or if you communicate with us through the Additive Minds Academy, and you are already a customer, or if a customer relationship is subsequently established, the information from the registration or submitted through the contact form will also be stored in your customer account and processed and used as part of your customer account. If a customer relationship does not exist and is not subsequently established, we will also store your registration and the object of your interest in our database of prospective customers. You can find further information how we process customer and prospective customer data outside of the Additive Minds Academy in our General Privacy Statement (see Section 2).

Recipients

- Our Additive Minds Academy (including your user account and registration information for newsletters) is stored exclusively on servers in the European Economic Area.
- We use the services of NetDimensions (UK) Limited Company number 07167352 do 52 Old Steine, Brighton, East Sussex, BN1 INH, United Kingdom for supporting our Additive Minds Academy. He will have access to your data. We also employ other third party service providers for hosting, operating and supporting our Additive Minds Academy. - We share data with other companies of our group of undertakings. For further information on this please refer to our General Privacy Statement (see Section 2).

Your Rights

- You as the data subject have certain rights with regard to your personal data, which include the right to withdraw any consent you may have given at any time (provided that the withdrawal consent will not affect the lawfulness of processing based on such consent before such withdrawal), to demand access to your personal data (and certain information on their processing), to demand rectification of incorrect and completion of incomplete data, and/or in certain circumstances, also the right to demand erasure or restriction of processing, the right to right to object to processing, and/or the right to receive your data in a structured, commonly used and machine-readable format. You are entitled to lodge a complaint with a supervisory authority.
- We will not make any decisions without your consent which produce legal effects concerning you or similarly significantly affect you and that are based exclusively on automated processing (including profiling).
